Canon Law

Antichrist

Typist: We are at a critical time in the writing of the United States Constitution. It has to do with what is the 17th century Common Law. At that time, the deputy and the common law courts were still operating under canon law. The Queen of England would pray for the people, this is love. The judges cared about the people as you normally think of the Commandment of Christ & Moshe “love one another”.

The legal profession and judges do not receive a moral education. They practice law as applying logic, they are not even to venture into moral law. If “canon law” is uncomfortable a term, then think of Moshe who taught the 10 Commandments and other commandments over death, burials, eating that were the laws for a people. I call them antichrist. All they want are the corn laws, the NAFTA laws.

Do they care about the people? Have you ever read from any law book the word “compassion”?

What George Washington said was that if you had a Madelyn O’Hara on Plymouth Rock with Roger Williams, she would be shot and killed. This is the antichrist removal of canon law and replacing it with legislative law. What was an automatic fight for the rights of others as the Puritans do was instead put into a framework of reasoning of the Scottish Enlightenment atheists.

They said that the word “antichrist” is not “atheist” as you call Thomas Jefferson an atheist lawyer.
