The Karmic Percentages

At this time of teachings of this judgment, we have had many questions of whether your karmic percentage that had been given to you applies. The categories of karmic percentages included the accuser of the brethren, false hierarchy group, the SPP to close down Summit University and those who remained on staff.

What has been forgiven are the ones not directly related to headquarters and the destruction of the Church. You had not known of the Karmic Board manipulations to put in place the secret ray buddhas. Yet the attrition and PTSD found in the staff has karma that must be balanced that is not from a demon possessed state such as with the accuser of the brethren.

Keepers of the Flame have been severely traumatized and it is a group karma, that they had changed the board policies to consolidate power. To lie to the press that they had hundreds of study groups forming and prayer vigils ongoing of 150 nations.

We would then say the denial of the Chohans whether El Morya or Saint Germain has a karma. These were your personal sponsors and the organization sponsors, and yet, the staff being in physical embodiment would refuse to do what was asked including the broadcast of decrees for over two years. This karma is, as they pointed out, substantial—as the missed decrees is the cause of many of the world conditions. The longer the decrees are not broadcast, there is further and further deterioration of the Church. The Keepers of the Flame do not have an altar to meet. There is not the feeding of body and blood of Christ.



The organization of 20,000 has been reduced to 2,000 of mostly onlookers, and not what you have known in the past as the true Church.

The scattering of Israel has a great karma associated, and this we have assigned the karmic percentages to these. It is a group karma that cannot even be balanced truly if this Church organization fails that none desire to occur. The teachings have the keys for the golden age.

The killing of the two witnesses was prophesied. You may say that this is the reason for what had happened. However, even when El Morya had returned in February 2011 with the mandates for the broadcasting of decrees and to move the organization forward, there was the denial in saying, "I do not think this is El Morya speaking."

You would have known the Master El Morya speaking to you as he has been your personal sponsor. Thus you know that these did not desire to lose their retirement plans and large salaries from the sale of lands.

Many of these have subsequently left the teachings. Those of our concern are those who have diligently done decree work to balance this karma. We would say then that this karma will not be adjudicated truly until there is a broadcast of decrees, services and conferences. There cannot be an adjudication unless we see additionally that there is the establishment of the outer Church that Church Universal and Triumphant will survive, as it will survive by having an outer Church primarily.

Thus it behooves you to try to see how you can contribute to this effort in time, expense and effort. Some of you have knowledge of headquarters that others do not have, you would try to pass that knowledge to the leaders in writing if not in person.

There are a few of the staff who had not been leaders however. These are individual by individual cases. The Karmic Board said the Montessori teachers do not count as their service was primarily one of teaching. But you saw how there was the one who wiped out the entire database of Keepers past a set number of years and this one would then need to balance this karma other than to serve as a leader again. Some of you already know that the Karmic Board had said that these who destroyed the organization cannot participate in the future organizational meetings.

Some have the karma from Suern that was an ancient karma that had been repeated in this century. Thus each ones karma is made known, however, we have had this series of teachings from Lord Maitreya and myself primarily to teach those who are dedicated to not losing the teachings and desire to move forward, primarily those with the sex tramp demon issues; the PTSD, the

lukewarm, the faithless, the hopeless and depressed issues, that they have not been able to move forward without some love and faith, understanding and guidance.

You ask, "What if I have given the decrees to balance the karma the Karmic Board gave?" These then will have seen a tethering to hierarchy and it is stored in your casual body as good works as you have done what has been the works of Christ. You have actually helped in your decree work whether in the nation or in this Church. You can be thankful to have had this blessing to have done the decree work on faith, as it is primarily that Alpha and Omega, the Elohim and Archangels have seen to making sure that karma is adjudicated as not all was in order at this time that is called the killing of the two witness period.

Those who have written the books must remove them. There is still much work as doing the *Frequently Asked Questions* section for the website, the opening of Summit University, the gathering of those who are the children born in this community to ascend. Without these conditions righted, the karma is but only held in abeyance for some future time.

Do that which is to preserve the path of Christ, that future generations might find the Christ way that keeps the flame on earth burning. Move this Church forward in Christ's name.
